Hwy: Mulch for the playground will be delivered June 20<sup>th</sup>. Help to distribute the mulch on Saturday June 22 will be needed.

Gravel has been put on Rohr Hill. Property on the seasonal part of the road has been sold to a new owner, with the possibility of permanent residence. Connisarauley road paving will be done next week, weather permitting. Tom met with a representative from STW who does aerial photos and will do a blank map of the new town property. Tom told the board culvert replacement will take place on Traffic Street. He stated that benching will be done.

Councilman Bill Spors told Tom OSHA considers benching illegal and the town will be fined if he proceeds using this method.

Supervisor: Ann Rugg told the board if the town was to be declared green and clean there are DEC grants available. CEO Jeff Holler told the board there are many regulations for the town to be declared green and clean. Ann will contact Brian Church regarding the master plan the planning board is currently working on.

CEO Report: Jeff completed 11 inspections, answered 24 phone calls, and sent 3 violation notices.

A motion was made by Bill Spors and seconded by Sid Barber to adjourn at 7:08 PM. Forster, Spors, Barber, Sherman and Rugg were in favor. Motion carried.
